In terms of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with SEBI Circular dated 09.09.2015, we would like to inform you that the Company has received an order passed by Debt Recovery Tribunal – I, Delhi ("DRT Order") for proclamation of sale of 16,19,820 shares of the company held by Mr. Anoop Bishnoi (1,92,960 shares) and M/s Surabhi Family Trust (14,26,860 shares) respectively, both forming part of promoter group of the Company. As per the DRT Order, the said shares have been directed to be sold on 11.08.2021 in Block Deal in the Bombay Stock Exchange / National Stock Exchange platforms in terms of the SEBI Guidelines on Block Deals through the Broker, HDFC Securities Ltd.
